

## WINDHAM SCHOOL BOARD

MINUTES OF MAY 9, 2007

### SPECIAL MEETING

Members of the Windham School Board met on May 9, 2007 in Conference Room # 1 at Windham Town Hall for a Special Meeting, immediately following a Workshop. Present were Chairman Kate Brix, Jeff Vermette, Donna Cobb, Jeff Pierce, Mary Wassick, Mike Duffy, and Superintendent Sandy Prince. (Toby Pennels is on Military Leave.)

#### **Teacher Contract Status**

On a motion by Jeff Vermette, Seconded by Mary Wassick, the School Committee voted 6-0 to approve the Superintendent's recommendation to grant second-year probationary status for the 2007 – 2008 school year to the teachers listed on Attachment # 1.

On a motion by Jeff Pierce, Seconded by Mary Wassick, the School Committee voted 6-0 to approve the Superintendent's recommendation to grade continuing contract status for the 2007 – 2008 school year to the teachers listed on Attachment # 1.

Teacher Heidi Lebel was moved from 2<sup>nd</sup> Year Probationary status to Continuing Contract status. She had been listed incorrectly.

#### **Appointments**

On a motion by Mary Wassick, Seconded by Jeff Vermette, the School Committee voted 6-0 to approve the appointment of Stephen Chabot as a High School English Teacher for the 2007 – 2008 school year, at a salary of \$35,901 (Masters, Step 3).

On a motion by Mike Duffy, Seconded by Mary Wassick, the School Committee voted 6-0 to approve the appointment of Nicole LaFlamme as a 5<sup>th</sup> grade teacher for the 2007 – 2008 school year, at a salary of \$30,752 (Bachelors, Step 1).

On a motion by Mike Duffy, Seconded by Jeff Vermette, the School Committee voted 6-0 to approve the appointment of Bobbi Maunsell as a 4<sup>th</sup> grade teacher for the 2007 – 2008 school year, at a salary of \$38,760 (Masters, Step 5).

On a motion by Jeff Vermette, Seconded by Jeff Pierce, the School Committee voted 6-0 to approve the appointment of Agnes Reichl as a Grade One Extended Learning Class Teacher for the 2007 – 2008 school year, at a salary of 44,340 (Bachelors, Step 11).

On a motion by Mary Wassick, Seconded by Mike Duffy, the School Committee voted 6-0 to approve the appointment of Brody Artes as a High School Math Teacher for the 2007 – 2008 school year, at a salary of \$30,037 (Bachelors, Step 0).

On a motion by Mike Duffy, Seconded by Jeff Pierce, the School Committee voted 6-0 to approve the appointment of Daniel Wirtz as a High School Science Teacher for the 2007 – 2008 school year (Bachelors +30, Step 3). There was discussion on whether this was a full-time or part-time position

as Mr. Wirtz currently teaches science part-time. The Board agreed to a friendly amendment not to include the salary in the motion to approve.

On a motion by Jeff Pierce, Seconded by Mike Duffy, the School Committee voted 6-0 to approve the appointment of Jessica Morin as a 5<sup>th</sup> grade teacher for the 2007 – 2008 school year, at a salary of \$30,307 (Bachelors, Step 0).
